Good morning Bhabesh, following our call this morning, you were looking for confirmation of the current licence 3BM-IGL1520 and its consideration of the planned construction of the new water intake and truck fill for the community's freshwater intake and supply. In review of the licence, the application and technical review carried out, these aspects were considered and the licence included further requirements of the licensee to provide as built drawings of the facilities and revised O&M manuals upon completion of the construction. This commitment was included in the technical summary document provided with the application. It also stated that "...the design and construction of the water storage reservoir is on hold." This aspect of the Hamlet's water system upgrading will need to be addressed in a further amendment application.

I was unable to confirm in our files the receipt of one of the documents regarding the Water supply design, but will confirm that with you later.
