As follow-up to our telephone conversation today, the NWB notes that the following requirements for the above-mentioned Licence, which was issued on March 31, 2015, remain outstanding:

1. Part F, Item 1 - Submission of an Operation and Maintenance Manual for the sewage and solid waste disposal facilities, within 90 days of issuance of the Licence.
2. Part F, Item 2 – Submission of amendments to the Operation and Maintenance Manual for the water distribution facility, as an addendum within the annual report.
3. Part H, Item 8 – Submission of a Quality Assurance/Quality Control Plan, within 90 days of issuance of the Licence.
