Hi Karén,

I am writing to follow up with the SDR issued by the NIRB for the GN-CGS' "Water Licence 3BM-IGL1520 Amendment #2 Hamlet of Igloodik" to the Minister of Indigenous Affairs and Northern Development and the NWB on May 13, 2016. I have received many phone calls from Bhabesh Roy from the GN-CGS on the status of the Minister's decision and next steps. I have explained that the Minister has 15 days to respond to a NIRB decision per Section 93.1 of the NuPPAA and that we rarely see a response, but assume per section 93.1(3) that if we do not hear a reply it has been approved. I have also explained that he needs to be discussing with the NWB the next steps forward and working with you regarding his application. Bhabesh is uncertain about the next steps with the NWB and the NWB process; perhaps you could contact him?
