A. BACKGROUND

The Government of Nunavut Community and Government Services (GN-CGS) manages the Nunavut Water Board water licence for the Hamlet of Igloolik, which permits Municipal Undertakings including potable water withdrawals and storage, operation of truck fill stations, wastewater collection and treatment, and the operation of waste management sites. The Hamlet of Igloolik 2021 Annual Report provides information on project activities for the Hamlet of Igloolik from January to December, 2021, as required by Part B Item 1 of Water Licence No. 3AM-IGL2131.

CIRNAC provides the following comment and recommendation pertaining to the 2021 Annual Report. Documents reviewed as part of this submission can be found in Table 1 of Section B. Detailed technical review comments can be found in Section C. References are in Section D.

C. RESULTS OF REVIEW

1. Reporting Requirements

Comment:

Part B Item 1 of water licence 3AM-IGL2131 outlines the annual reporting requirement to be included in the Annual Report. The following data is not reported in the 2021 Annual Report.

- Monthly and annual quantities in cubic metres of sludge removed from the Wastewater Treatment Plant
- The QA/QC program for all the data collected under the monitoring program

Recommendation:

(R-01) CIRNAC recommends that GN-CGS provide clarity on whether any sludge was removed in accordance with Appendix D of the operations and maintenance plan for the Wastewater Treatment Facility. If so, indicate the monthly and annual quantities (in cubic meters) of sludge removed.

2. Spills

Comment:

Section vii of the Annual Report for the Hamlet of Igloolik states that "The New Iagoon cell-1 is reported leaking at the upper side of the berm". Additionally, in the CIRNAC inspection report it was noted under section spill report 2021-372 that the "Hamlet of Igloolik didn't provide the right sample analysis" for the breach at lagoon 1.

Section V of the Annual Report "A list of unauthorized discharges and summary of followup actions taken" states that the leachate at the dump site is uncontrolled however, testing are conducted each summer.

Recommendation:

(R-02a) CIRNAC recommends GN-CGS fix the berm at cell-1 and collect the correct samples from the spill site and record them appropriately for the responsible Water Resource Officer with CIRNAC. Confirm that the spill line has been updated as per Part H:5(c) on the spill report 2021-372.

(R-02b) CIRNAC recommends that GN-CGS provide a plan as to how they plan to control the leachate at the new and modified dump site as well conduct the sampling and report on the results from the leachate testing that occurs every summer.

3. Bulk Metals and Hazardous Waste

Comment:

In the annual report it is noted that there are concerns related to the segregation of hazardous waste materials, storage of these materials and their shipment to the south. In the 2021 WRO inspection report noted concerns specific to bulk metals and hazardous waste with actions required as stated below:

- Maintain fencing at Water Storage Reservoir
- Segregate the Bulk Metals, and Hazardous Waste;
- Consolidate all Hazardous Waste and store in such a way as to protect water from mixing with the hazardous waste; and
- Provide the inspector with a copy of or the location(s) of the modified Solid Waste Disposal Facility.

Recommendation:

(R-03) CIRNAC recommends that GN-CGS provide a plan to segregate, store and ship hazardous waste materials. As well respond to what actions they have undertaken to maintain compliance with the orders provided in the Inspection report by the Water Resource Officer.

4. Lab Results

Comment:

The test lab results for the 2021 annual report are not provided on the Nunavut Water Board registry.

Recommendation:

(R-04) CIRNAC recommends that the lab results be distributed to allow proper review of the data.

5. Abandonment and Restoration work

Comment:

According to the 2021 Annual Report the scheduled work to abandon the existing truck fill station and dump site have been delayed due to the COVID 19 pandemic. These projects have no proposed timeline for completion.

Recommendation:

(R-05) CIRNAC recommends that GN-CGS provide an updated timeline for this work to be completed.
