Subject: Type “A” Water Licence No: 3AM-IGL2131; Municipality of Igloolik

Dear Honourable Minister Vandal:

Please find attached a copy the Type “A” Water Licence No: 3AM-IGL2131 (Licence), duly issued by the Nunavut Water Board (NWB or Board) to the Municipality of Igloolik for a Municipal undertaking in accordance with Schedule 1 of the *Nunavut Waters Regulations*. This Licence authorizes the continued use of Water and deposit of Waste at the Municipality of Igloolik and will replace the expired Type “B” Water Licence No: 3BM-IGL1520.

In its decision to issue the Licence and consistent with the *Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada (Nunavut Agreement)*, the Board considered the outcome of its review process as well as the determinations made by the Nunavut Planning Commission (NPC) and the Nunavut Impact Review Board (NIRB) with respect to the undertaking.

The NPC in its February 26, 2020 correspondence¹ confirmed that the project proposal is outside the area of an applicable regional land use plan and the NPC's previous conformity determinations dated December 30, 2008, August 13, 2014, March 31, 2015, June 9, 2015, March 1, 2016, and most recently December 20, 2019 still apply, and that the Application is exempt from further screening by the Nunavut Impact Review Board (NIRB) because the Application did not change the general scope of the original or previously amended project activities already assessed by NIRB. The NIRB has previously screened the works and activities associated with the current proposal, including a Type "A" Water Licence, and a Screening Decision Report was issued on May 13, 2016 (NIRB FILE No. 15UN040).

In accordance with section 56 of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act*, the above referenced Licence requires your approval and, as such, the NWB submits the attached Reasons for Decision including the Record of Proceedings along with a copy of Water Licence No: 3AM-IGL2131 for your consideration.
