The Nunavut Water Board (NWB) is in receipt of comments¹ concerning the information requirements and procedural issues related to the amendment application for the City of Iqaluit's Type A water Licence. As you may recall, in a letter dated May 20, 2009, the NWB asked interested parties to comment on the following:

- The type and form of public hearing in order to consider the Type A Licence amendment;
- The relevance of the information deficiencies identified in the preliminary assessment of administrative compliance in relation to the processing of this Application;
- Any additional information the parties may require in order to process and evaluate the merits of the amendment requests listed above and in the submitted documentation; and
- Any other matters relevant to the Application and process.

Comments were submitted by Indian and Northern Affairs Canada, Environment Canada, the Government of Nunavut Department of Environment, and a concerned citizen. These comments are available on the NWB's ftp site at the following link:

The NWB's letter of May 20, 2009 also asked that the City of Iqaluit (Applicant) provide a timeframe for the submission of outstanding information. The NWB specifically informed the Applicant that the

requested information is an important component of the application and that processing of the request would be held pending its receipt.

As there has been no response from the applicant, the NWB is again requesting that the Applicant provide a timeframe for the submission of all outstanding information. In the event that a commitment is not received and an update is not provided by **February 8, 2010**, the NWB will proceed to close the file.
