Good Morning Muhamud,

In December 2016 the NWB received an application for amendment to 3AM-IQA1626 water licence. The NWB was also told in January 2017 that the application could be changed to combine a number of amendments.

The NWB would like to know whether the City will proceed with this amendment in 2018 or not. As this is a Type "A" water licence that the amendment process will include a public hearing, the NWB needs updates on this to plan NWB activities/budgeting for upcoming fiscal year.

Also, please note that if the scope of 2016 amendment application is going to be changed for future processing, the City needs to go through Nunavut Planning Commission (and potentially Nunavut Impact Review Board) review process before the NWB proceeds.
