Thank you for the application submission in such a timely fashion. Just a couple of quick points of clarification with respect to this application.

- 1. The duration of this emergency amendment will only be for the 2019 pumping season, this was previously confirmed but the application submitted incorrectly indicates till 2026;
- 2. For these activities specifically (i.e. 2019 Apex River pumping), they were again reviewed by NPC and a positive conformity determination was issued on January 11, 2019.
