On February 22, 2007, the Nunavut Impact Review Board (NIRB or Board) received the city of Iqaluit's Trail Area Deposit-Quarry Development project proposal from the Government of Nunavut, Community and Government Service (GN-CGS) in Iqaluit. NIRB assigned this project proposal file number, 07QN020. After a pre-screening review it was determined that NIRB required additional information from CGS prior to commencing the Part 4 Screening for the project proposal. On March 21, 2007, NIRB received the additional information from the GN-CGS necessary to commence the Part 4 Screening.

The project activities include:

- Quarrying - Extraction of granular material
- Overburden Removal – 1 metre or less
