Further to the Nunavut Water Board's (NWB or Board) correspondence¹ of June 19, 2020, with respect to the technical review of the Type "A" Water Licence Application 3AM-IQA1626 and supporting documentation (the Application) submitted by the City of Iqaluit (the Applicant) for their municipal Water Licence, the Board received a request from the Applicant for an additional four weeks to provide a response to technical review comments received from Crown-Indigenous Relations and Northern Affairs (CIRNA) and Environment and Climate Change Canada (ECCC).

Copies of the comments received from Intervening parties, submissions from the Applicant and all documents associated with the Application have been placed in the Board's Public Registry and made available through the NWB's FTP site using the following link:

In its previous correspondence dated June 19, 2020, the Board directed the staff of the NWB to hold a Technical Meeting and Pre-hearing Conference (TM/PHC) by teleconference during the week of August 10th. The Applicant has since requested a submission extension to September 1, 2020, and accordingly, the Board has revised the timeline for the licensing processes next steps, including the TM/PHC rescheduled now for the week of September 14, 2020 (tentatively on September 15 and 16, 2020), as outlined below.

Next Steps Preceding the Technical Meeting

June 17, 2020: (Completed)	Commencement of the technical review period; parties are asked to provide their technical review comments to the Board
July 17, 2020: (Completed)	Submission of technical review comments and representations to the Board.
September 1, 2020:	Applicant to provide response(s) to technical review comments. Parties given an opportunity to review responses from Applicant
September 4, 2020:	Circulation of draft agenda for the Technical Meeting.
September 10, 2020:	Submission of Applicants and Interveners presentations for the proposed technical meeting (including translated versions). Confirmation of attendance and draft agenda.
September 11, 2020:	Circulation of final agenda for the Technical Meeting / Pre-Hearing Conference.
Week of September 14, 2020 (tentatively on September 15 on 16, 2020)	Technical Meeting and Pre-Hearing Conference

During the Technical Meeting the Applicant and intervening parties will be required to provide PowerPoint (or PDF) presentations pertaining to the City of Iqaluit's Application and the technical review submissions to the Board. It should be noted that intervening parties are expected to indicate during their presentations whether or not the issues that they have identified have been or will be addressed by the Applicant to their satisfaction prior to the Board's processing of the Application proceeding to a Public Hearing. Intervening parties are requested to provide executive summaries of their interventions complete with French and Inuktitut translations.
