RE: Prepare an addendum to the Landfill Operations and Maintenance Manual to include the current sampling program

Dear Mr. Kharatyan:

On January 13th and 14th, 2016, representatives of the City of Iqaluit (City) attended the Technical Meeting, Public Meeting and Pre-Hearing Conference for the renewal application of Water Licence 3AM-IQA0612. During the meetings, Indigenous and Northern Affairs of Canada requested the City to prepare an addendum to the Landfill Operation and Maintenance Manual to include the current sampling program.

The City agrees that the sampling program should be included in the Landfill Operation and Maintenance Manual, however, the City requests that this be completed by including reports/plans related to the sampling program as appendices rather than preparing addendums.

The City is submitting a second, related letter regarding the schedule to update the Management Plans that were submitted with the Water Licence Renewal Application. In that letter, the City committed to updating the West 40 Drainage Management Review, the City of Iqaluit Water Licence Monitoring Program and the City of Iqaluit Quality Assurance/ Quality Control Plan to include the potential changes in Water Licence 3AM-IQA0612 within 180 days following the issuance of the Licence.

The City requests that, as a condition of the renewed water licence, it be required to revise the Landfill Operation and Maintenance Manual, to include the three (3) reports listed above, as appendices, within 90 days of the Nunavut Water Boards approval of the three (3) updated reports. This ensures the Landfill Operation and Maintenance Manual contains the most current information from the associated Management Plans.
