Subject: City of Iqaluit Public Hearing Adjournment

Dear Mr. Baker:

As decided on March 9, 2006, the Board has adjourned the hearing in order to allow for additional submissions as follows:

1. [All parties] With respect to the lands which the City proposed to use as an extension of its current landfill, is there any impediment to the Board's licensing the landfill extension, either by virtue of the fact that ownership (administration or control) of the lands is in dispute (between the GN and Government of Canada), or by virtue of the fact that the lands may be contaminated? In answering this question, please keep in mind the issue of future Abandonment and Reclamation of the site;
2. [City] The City of Iqaluit is to review and respond to the submissions of M. Jim Little and Ms. Siu-Ling Han;
3. [City] The City of Iqaluit is to submit a revised workplan (exhibit 29); and
4. [City] The City of Iqaluit is to submit information on fecal coliforms as requested by NWB staff Dionne Filiatrault.

The hearing will reconvene on **March 24, 2006, starting at 9:00 am at the Frobisher Inn** meeting room. Please note that the Chairman of the NWB incorrectly stated at the end of the hearing that the Board would reconvene on March 25, 2006. We apologize if this has caused any conflict with your respective schedules.

Parties that cannot attend in person may join the hearing via teleconference. Please contact the NWB office to obtain instructions to do so. Parties will be given the opportunity to respond to other parties' submissions, and make final closing statements. The agenda is enclosed. On the matter of the landfill expansion, the Board encourages all interested persons and in particular the City of Iqaluit, the Government of Nunavut and the Department of Indian and Northern Affairs Canada to explore the possibility of a joint submission, and to copy their respective submissions to other parties and to the Board at least two days before the hearing.
