Mr. Sayani,

With regard to your latest inquiry and to the cemetery project identified in an earlier email (I believe Dionne Filiatrault had received a phone message from Michelle Bertol at some point in this process as well), and in the absence of any additional information that the NWB was looking to receive from INAC Waters, the NWB has determined that a water licence application is not necessary at this time.

From the information provided, there does not appear to be any direct or indirect use of water, including any instream-use, water course training or alteration of water course or its banks, crossings (culverts/bridges), alteration of flow or storage (reservoirs), and others, or a deposit of waste where there is a direct or indirect deposit to surface waters. You have indicated that the project is to be set back a minimum of 50m from the nearest water body which is beyond normal setbacks required by the NWB (measured above the normal high water mark), and considering general construction procedures in place, sediment and erosion control measures, that should be implemented prior to and maintained during the operation to prevent entry of sediment into water, mitigation should be adequate to remove any potential waste discharges. Please keep in mind that should discharge of waste take place to a water body, the activity may be in violation of the Nunavut Waters and Nunavut Surface Rights Tribunal Act, as well as appropriate sections of the Fisheries Act (if into a fisheries habitat), as well as others.

Should the scope of the project change from what has previously been indicated, please contact the NWB or INAC Water Resources (and Inspection) for further assistance.
