

We have encountered a failure in our level detection system that requires immediate priority replacement which we are working on. This process may take 2 weeks to complete due to sourcing stock parts. The decision to decant immediately is based on high levels in the lagoon due to rain and diverting to lagoon to allow for major reconstruction of our new waste treatment facility.

Please grant permission to decant immediately and I look forward to your positive response and working together to resolve this temporary set back. I understand you fly out today so I look forward to your return when we can inspect the facility upon your return.
