Good evening Assol:

I understand that the Canadian Armed Forces (CAF) are looking to adjust their workplan, given recent challenges with the weather in Iqaluit – their operations were suspended earlier in the week, as strong winds had damaged a tent, which provided an enclosure for the ROWPU.

Their new workplan will still consider pumping water from the Sylvia Grinnell River; however, it will now be trucked to an existing military hanger hear the Iqaluit International Airport – the ROWPU will be located there. The adjustment from the plan is the handling of the return water (discharge from the ROWPU). As per the CAF original workplan, their return water (concentrate) was going to be discharged into a ravine, which would ultimately discharge to the Sylvia Grinnell River. Wash water (or waste generated when cleaning the unit with chemicals) would be neutralized and discharged into the City's Sewage Lagoon, as per the Sewage Lagoon O&M. The CAF is now requesting to discharge the return water into a pond near the military hanger (see photo below for reference).



With respect to discharging concentrate, the City would also like further clarity regarding instructions provided by the NWB, which requested that waste product from the ROWPU be discharged to the WWTP. As per the CAF original workplan, they were seeking to discharge concentrate (return water) to the Sylvia Grinnell River, as this water would essentially contain dissolved salts and minerals as a result of the ROWPU. This water would be obtained from the source, and contains no chemicals. The wash water (waste product) would be discharged into the sewage lagoon, as the mixture contains water and chemicals used during the filter washing process. The wash water would be neutralized as per the parameters set within the Sewage Lagoon O&M. Can you confirm the NWB understanding of the term waste product? Does this include just wash water, or both wash water and return water?

Dear all,

To clarify, the permitted <u>raw</u> water withdrawal rate from the river is 350 m3/day. This is the permitted maximum rate withdrawn at the intake at the river.

Concentrate (waste product of the ROWPU, as we understand from the submitted document package) is to be hauled to the wastewater treatment plant.

To amend the licence to increase withdrawal rates, the City will need to go through the same process as with the emergency amendment issued on October 15.

Notes:

City requires 24 hours to disinfect trucks and tanks to accept new water. We plan to start the process on Monday

Water license permits a total withdrawal limit of 350,000L per day from Sylvia Grinnell River. It is expected that we can work within this limit if the concentrate is not included in these numbers. If not, we work to amend the license.


