The repairs include the following:

Inspection of all vertical, and horizontal pour joints

- Injection of new sealant where required
- Inspection and localized repairs of all upstream concrete surfaces
- Installation of a new fish screen at the water intake.

Environmental protection of the water intake will be maintained during construction including controlling and minimizing particulates and water turbidity. The proposed repairs are shown on the attached drawings.
