As presented in our conference call dated September 19th, 2018, and as recommended by Stantec in their letter, which is based on the samples results of the lagoon treatment. It was recommended to continue to use the lagoon as a treatment unit until the commissioning of the new equipment in the WWTP (end of January 2019). This is a better option than using the current equipment in the WWTP.
