Dear Mr. Clow,

On June 27, 2008, the Nunavut Water Board (NWB or Board) received a document entitled “*City of Iqaluit Water Licence Monitoring Program*” (Plan) from the City of Iqaluit (Licensee) in accordance with Part I, Item 4 of Water Licence 3AM-IQA0611 (Licence). The NWB distributed the Plan to interested parties on July 8, 2008 with a request for written comments. By September 8, 2008, the NWB was in receipt of comments from Indian and Northern Affairs Canada (INAC) and Environment Canada (EC). The comments can be obtained from our ftp site, using the username of “public” and the password of “registry”, without the quotes.

The NWB understands that the City of Iqaluit is preparing to submit the outstanding information related to its Application for Amendment to Water Licence 3AM-IQA0611 (Application) in the coming weeks. As such, the NWB encourages the Licensee to take parties’ comments on the Plan into consideration in the preparation of its Application, particularly with respect to the following issues:

1. Effect of the current renewal / amendment application on the Plan;
2. Raw water monitoring;
3. Wastewater treatment plant influent monitoring;
4. Wastewater treatment plant effluent monitoring;
5. Landfill runoff monitoring;
6. Sewage sludge monitoring; and
7. General format.

These issues, summarized in the attached spreadsheet, must be addressed prior to Board approval of the Monitoring Plan required by Part I Item 4 of the Licence.
