Hello Justin, Richard, Neil and Derek,

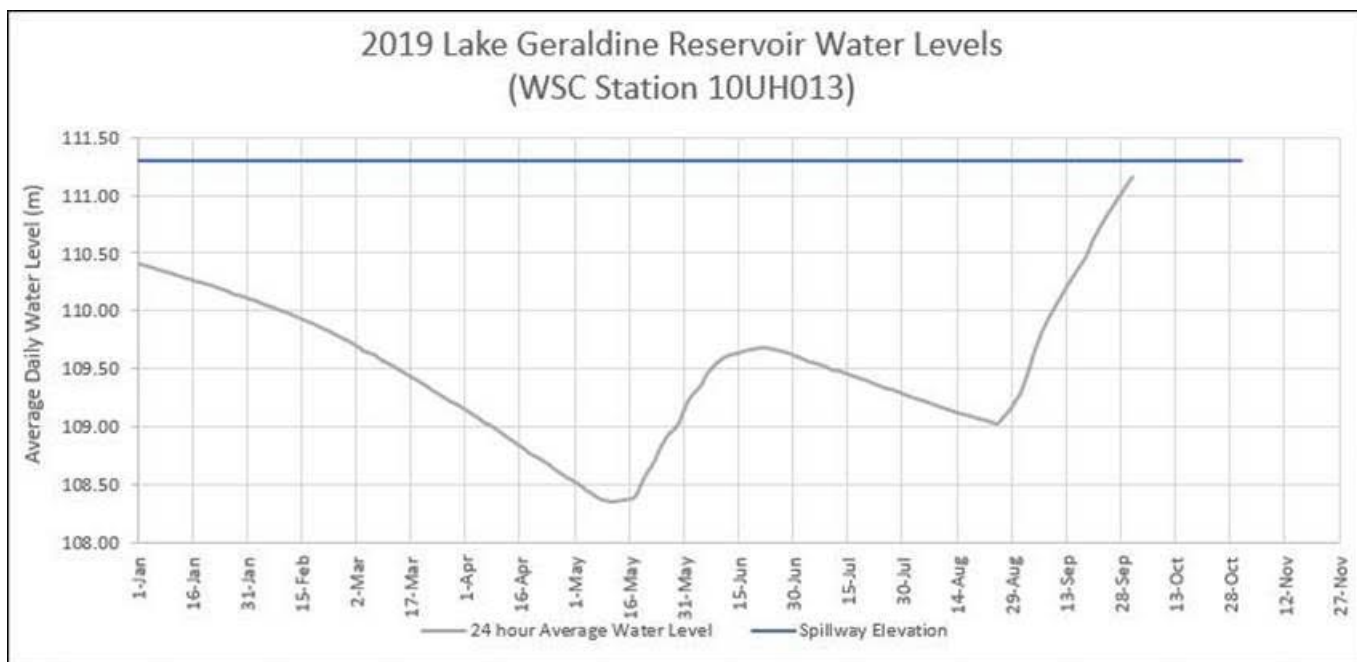
As of October 1, 2019 supplementation of the Lake Geraldine Reservoir from Apex River and Unnamed Lake has been completed.

Pumping Summary:

- Cumulative 462,394 m³ pumped from Unnamed Lake (IQA-13)
- Cumulative 566,314 m³ pumped from Apex River (IQA-10)

Lake Geraldine Reservoir:

Average water level for October 1st was 111.154 m. The highest water level recorded on October 1st was 111.165 m.



Apex River:

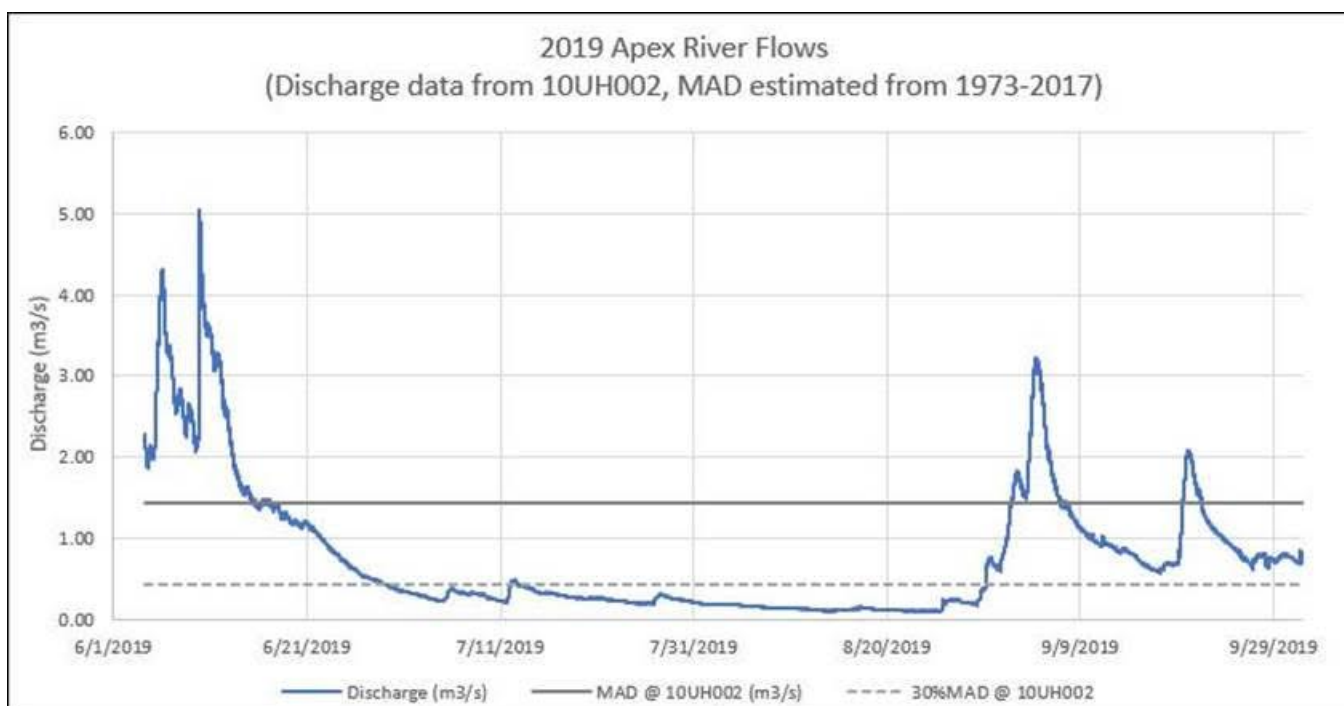
Average 24-hour discharge at WSC station 10UH002 on October 1st was 0.734 m³/s.

Withdrawals at SNP-10 exceeded the 10% of the instantaneous natural flow (averaged over a 24h period) on:

September 16 (0.003 m³/s)

September 25 (0.002 m³/s)

September 26 (0.011 m³/s)



Also attached are daily records as based on the Operational Monitoring Plan.
