Thank you for your letter of May 13, 2011, and accompanying background material that requested my consent to waive the requirements for notice and a public hearing associated with an emergency amendment to extend the term of the City of Iqaluit's Type "A" Municipal Water Licence No. 3AM-IQA0611 and to sign the amendment.

In accordance with sections 55(5) and 174(1)(a)(ii) of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act*, I hereby consent to waiving the notice period and requirement of a public hearing for this emergency amendment as recommended by the Nunavut Water Board and have signed the amendment, effective immediately. As required by the *Nunavut Waters and Nunavut Surface Rights Tribunal Act*, I have also copied this letter to the City of Iqaluit to inform them of my consent and to include a copy of the signed amendment.

However, I understand that the City did not apply to renew its licence with due consideration to guidelines and past practices and still has not submitted for a renewal other than this 14-month extension. I am becoming more concerned about the use of emergency amendments to address largely administrative matters. I would like to see our respective officials meet to discuss other mitigative measures to address these types of circumstances.



Thank you again for your letter and for the diligence exercised by the Nunavut Water Board and its staff in proceeding with this amendment. This emergency amendment will allow the City of Iqaluit to continue to provide municipal services while developing a comprehensive plan to move into compliance with their licence issued by the Nunavut Water Board.
