RE: 3AM-PAN---- (3BM-PAN1417), Type "A"; Renewal – Amendment Application for the Hamlet of Pangnirtung's Municipal Water Licence

Dear Messrs. Roy and Ladd:

As a follow-up to the Nunavut Water Board's (NWB or Board) June 9, 2017 correspondence in which interested parties and/or persons were invited to provide technical review comments for an Application submitted by the Government of Nunavut – Community and Government Services (GN-CG&S), on Behalf of the Hamlet of Pangnirtung (the Licensee or Proponent) to renew and amend Licence No. 3AM-PAN1417, the NWB has been in receipt of three (3) separate submissions from the following intervening parties:

- Environment and Climate Change Canada (ECCC);
- Fisheries and Ocean Canada (DFO); and
- Indigenous and Northern Affairs Canada (INAC).

The Licensee should note that the NWB has changed the name of the file to reflect the fact that the Application is currently being administered in accordance with the NWB's typical Type "A" water licensing process. Despite the aforementioned change, access to the documents associated

with the Application is made available under the old as well as the new file names and both file names are being used interchangeably.

The NWB advises that the Proponent thoroughly review the submissions received from the intervening parties referenced above and provide its response(s) on or before **August 25, 2017**, **4 p.m., Mountain Standard Time**.

Following receipt of the Proponent's response(s), the NWB will issue correspondence regarding the next step of the licensing process (the Technical Meeting and Pre-Hearing Conference Stage) for the Application to renew and amend Licence No. 3BM-PAN1417.
