Further to the Nunavut Water Board's (NWB) October 30, 2017 correspondence in which interested parties were requested to confirm their intended participation and provide feedback on the proposed agenda for the Technical Meeting and Pre-Hearing Conference, scheduled for December 5 – 6, 2017 for the Hamlet of Pangnirtung Type "A" Water Licence Application, the NWB received confirmation of participation from the Proponent, the Hamlet of Pangnirtung, Environment and Climate Change Canada (ECCC), Fisheries and Oceans Canada (DFO), and Indigenous and Northern Affairs Canada (INAC).
