Hi NWB,

I'm writing this email to request an extension to comments on the Pangnirtung water licence application.

This is the licence that is changing from type B 3BM-PAN1417 to a type A.

In a written correspondence from the NWB it stated that the applicant was to provide comments to the board by June 23, 2017 in response to the Completeness/IR review stage. In the same correspondence the NWB indicated that the interveners were to provide comments by July 12, 2017.

This comment period is less than the normal 30 day technical review period that is normally given, with this file we have tried to meet this deadline however we can not possibly do an adequate and effective review of the information associated with the file by July 12.

We are therefore requesting an extension to the comment period to July 21, 2017.
