I am applying for a new water License of the Utilidor System of the Hamlet of Resolute Bay. Presently Community Government Services of the Government of Nunavut is Maintaining the Utilidor system through the O &M division at Cambridge Bay, although at some time in the near future this will be transferred to the Baffin Region. The Utilidor system was built in 1970 and no water license was obtained until today.

The Utilidor system is being rehabilitated and expanded. The construction is expected to complete in 2007. As soon as the GN and the hamlet of Resolute Bay are comfortable with the situation with the Utilidor system, and all upgrades are completed, the ownership will be transferred to the Hamlet following Nunavut Land Claims agreement.
