As a follow-up to our telephone conversation today, the NWB requires copies/responses pertaining to the following items:

- 1. Laboratory results for 2010, 2011, and 2012 reporting periods; no laboratory results were provided for the 2010 and 2011 reporting periods while the embedded laboratory results provided for 2012 reporting period cannot be viewed/opened;
- 2. Confirmation with respect to actual scope of the water licence renewal application; and
- 3. Provision of an updated Operations & Maintenance Manual (O & M) manual for the water and waste water system.

Please note that I will be discussing with Dave the suggestion(s) you raised surrounding requirement for an O & M manual.
