The Field Operations Unit of Aboriginal Affairs and Northern Development Canada is currently engaged in conducting our annual Risk Prioritization Exercise in preparation for the 2015 field season.

It has come to our attention that the above noted Water licenses for undertakings conducted by the University between 2010 and 2013 respectively have expired.

In 2014 an Inspection of the above licensed activities was conducted and reports were sent to your offices as well as those of the Nunavut Water Board. Those reports are again included as attachments to this email. Those reports detailed what if any outstanding requirements were to be addressed to ensure completion and closure of the files.

To date we have received no response from your office. Therefore the files will remain active within our system and continue to accrue fees and the liability for the sites.
