## **Project Start Dates**

As projects in the High Arctic are impacted by many factors (logistics, transportation, supply, weather, etc.), the project start dates are best estimates. Unforeseen circumstances may cause delays ranging from weeks to entire seasons. Given this factor, I have included the estimated project start dates (above) to these modifications.

## **Return Line Modification**

Previously, this Return Line contained warm treated potable water (with chlorination) along the water distribution pipelines to prevent the intake from freezing. Between the time of issuance of the Licence in 2010 and July 2011, a modification was completed to isolate the return line water from the treated potable water. The Return Line now carries warm raw water along the distribution system to prevent freezing damages and no longer uses any potable (chlorinated) water in the process.
