The Nunavut Water Board (“NWB” or “Board”) received from 8 Wing Environmental Management on behalf of the Department of National Defence (DND) the documents entitled “8 Wing Environmental Management Response to RE: Licence No. 3BC-ALT1015 “CFS-Alert” on July, 5, 2011, and the revised “Operational and Maintenance Plan CFS Alert (ALT), Nunavut” (Plan) on July 13, 2011 and August, 2, 2011. The Plan was originally submitted on November 30, 2010.

The NWB has completed a technical review of the revised Plan. The following documents were included with the O&M Plan as appendices:
