Good day Miss Beaulieu,

I called your office general phone line ([1-855-521-3745](tel:1-855-521-3745)) and left a voice message earlier today. Unfortunately, I don't have your direct extension. I wanted to discuss the reason why an application for the renewal of the expired NWB licence (3BC-AWW0814) has not been submitted hitherto.

Please note that the NWB annual report, and an application for the renewal of the current NWB permit have not been submitted to NWB because during the conduct previous and current iterations of the AOA (formerly WWA course), water is not drawn from the host community water bodies. Also, as stated in the AOA course descriptions attached, waste water generated during the conduct of the AOA activities is frozen, and transported for disposal in Trenton, and not in host communities, after the conduct of the AOA training.

We will be completing the AANDC Project Assessment 2015 form, for submission to AANDC. We would appreciate if you could kindly provide the necessary paperwork (forms) required for DND to submit a formal application for the cancellation of the expired NWB licence (3BC-AWW0814). Please note that I checked the NWB website, but was unable to find the link to the requested forms or your phone number.
