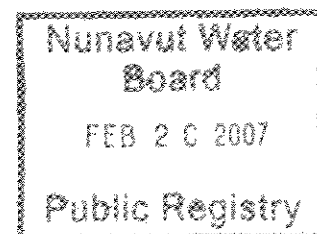

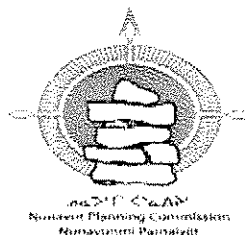
My office would be pleased to discuss these with you how to best implement these requirements and to review any draft authorizations that you wish to provide for that purpose.
