The Canadian Forces is planning an Arctic exercise near Resolute in March and has applied for a short-term water licence for disposal of waste. The proposal is to transport all human waste back to Resolute (using ATCO Frontec). They need a letter of approval from the operator of the sewage system (perhaps the Hamlet &/or CGS) before the NWB will approve their licence.

The Forces alternative is to haul all human waste back south to Yellowknife.
