### Comments:

#### A. Background

On March 29, 2016, the Nunavut Water Board (NWB) invited interested parties to review the Department of National Defence's application for the cancellation of Type B water licence 3BC-AWW0814. The Department of National Defense (the proponent) is seeking to cancel 3BC-AWW0814; the water use licence for their Arctic Operations Advisor course. The Arctic Operations Advisor course (formerly the Advanced Winter Warfare course) involves a winter training course for Canadian Forces personnel that has operated (under 3BC-AWW0814) since 2008. The course is run each winter over a period of ~14 days and operates temporary camps in locations near Arctic Bay, Cambridge Bay, Pond Inlet, Resolute, Taloyoak, Kugaaruk and Gjoa Haven (camp locations vary depending on the year). Most recent iterations of the course have occurred around Resolute.

In previous years of the course, water has been supplied from the community of Resolute in the form of ice blocks and as such, no water is drawn from water bodies at the camp locations. Waste has been frozen and transported with the course participants and then shipped to CFB Trenton for proper disposal. Greywater from the preparation of food has been cooled and returned to the land at ambient temperature. For continuing iterations of the course, the proponent has stated that water will continue to be supplied from the community of Resolute, and that all wastes generated by the course activities will be frozen, transported out with the participants and sent to a southern waste disposal facility. The proponent states that the NWB water licensing requirements do not apply to the conduct of the Arctic Operations Advisor Course.

## B. Results of review

On behalf of Indigenous and Northern Affairs Canada's Water Resources Division, the following comments and recommendations are provided:

### 1. **Expiration of licence and submission of annual reports**

**Comment:** INAC notes that the cancellation application applies to a Type B licence which expired in 2014, however course activities have continued since 2014. INAC also notes that the proponent submitted, when requested by the NWB, annual reports for all years (2008-2014) for which the current licence was valid.

### 2. **Discharge of greywater from food preparation to the land**

**Comment:** The proponent has stated in their licence cancellation application that no water is drawn from host community water bodies during the operation of the course, and that wastewater generated from the course is frozen, transported out with participants and disposed of at CFB Trenton. However, the proponent has also stated in their annual reports (including the most recent 2013 and 2014 reports) that water heated for either personal hygiene or to prepare dry food (i.e. greywater) is cooled to as close as possible to ambient temperature and released onto the land. INAC notes, though, that the proponent specifies that sewage and contaminated water are not disposed of in this way and are transported out with the course. As this licence expired in 2014 and no annual reports have been submitted since that time, it is unclear whether the course continues to operate under these guidelines (though this is assumed considering the cancellation application).

**Recommendation 1:** INAC recommends that the proponent consider whether the activities occurring during future iterations of the Arctic Operations Advisor course may require approval from the NWB for water use without a licence.

## C. Conclusion

Indigenous and Northern Affairs Canada recommends that licence 3BC-AWW0814 be cancelled and have included a closure recommendation from a Field Operations inspector (see attached).
