7. REASON – Provide written reason for cancellation request:
The license 3BC-BGI0813 expired September 2013. Prior to this date representatives from the Nunavut Water Board were contacted for advice in initiating the process of license renewal. At that time, we, the licence holders, were advised by representatives of the Nunavut Water Board that the scope and parameters of our research program would be better met by an annual Application For Approval For The Use of Waters or Deposit of Waste Without A License, rather than amendments to or an extension of a Water Use License.
Approval for Use of Waters or Deposit of Waste Without a License was applied for and granted 15 April 2014 (8WLC-BGI1415). Therefore License 3BC-BGI0813 can be cancelled.
8. ABANDONMENT MEASURES The following measures have been taken to address the final abandonment conditions required by the licence: (explain, with drawings, how abandonment conditions of the licence have been met; how stream channels have been rehabilitated; how tailings have been recontoured; how instream structures have been removed; and how waste materials have been disposed of. We intend to adhere to the guidelines for Abandonment Measures described in our License (3BC-BGI0813) in Part I: CONDITIONS APPLYING TO ABANDONMENT AND RESTORATION OR TEMPORARY CLOSING.
Our activities and impact on the landscape and watershed in our region of interest are minimal. No permanent structures have been built, no roads or airstrips have been graded, and the contours of the landscape have not been altered.
We shall, upon completion of our activities on the Devon Ice Cap, remove from the site, all site materials, including all fuel caches, barrels, camp material and equipment. An inventory of all materials stored on site is updated annually and will be used to ensure all materials are accounted for and removed from the site upon completion of our activities.
License 3BC-BGI0813 has been superseded by Approval for Use of Waters or Deposit of Waste Without a License (8WLC-BGI1415). Hence, our activities on the Devon Ice Cap have not ceased and we have not yet undertaken these abandonment measures. We continue to abide by all conditions listed in Schedule 1 : Conditions for the use of Water or Deposit of Waste Without a Licence.
9. CERTIFICATE OF COMPLETION: Application for Licence Cancellation must be accompanied
by either of the following: Application for Certificate of Completion enclosed; or Certificate of Closure enclosed.
NOTE:
A final inspection of the site has not yet been made by an AAND Inspector, and they will not issue a

Certificate of Closure until the inspection (planned for 2015) is done. AAND advised us to submit this application anyways, so that it is on file with NWB and the license closure process can be initiated.
