## RE: Review of 2010 and 2011 Annual Reports and Spill Contingency Plan(SCP) Addendum and Submitted for Licence No. 3BC-CBA1015

The Nunavut Water Board (NWB or Board) received the following documents in fulfillment of the relevant terms and conditions under Licence 3BC-CBA1015, issued for the Cape Bounty Arctic Watershed Observatory Project, located approximately 400 kilometres west of Resolute Bay within the Qikiqtani Region of Nunavut:

- ➤ 2010 Annual Report, required under Part B, Item 2 Received April 21, 2011;
- > 2011 Annual Report, required under Part B, Item 2 Received August 22, 2011 and
- > Spill Plan (SCP) Addendum, required under Part H, Item 2 Received June 30, 2011.

On May 5 and August 29, 2011, the NWB acknowledged receipt of the 2010 and 2011 Annual Reports, respectively, and distributed the documents publicly for information purposes. No comments have been received to date. NWB's staff has reviewed the Annual Reports and SCP Addendum and determined that the documents are mostly consistent with the respective terms and conditions under Licence 3BC-CBA1015. The Licensee is however reminded that all future annual reports must be submitted to the Board no later than March 31st of the year following the calendar year being reported.
