I am sorry that I am so late with my answer! During our last expeditions, we always returned our garbage back to the PCSP in Resolute Bay, and I always thought that the PCSP is taking care of the returned garbage. However, the garbage we are expecting in our base camp can be burned on the garbage dump. We can probably also burn our garbage in the field (but I don't like it very much!). We will not have bulky items, scrap metal, waste oil, hazardous waste or batteries. Most of our garbage will be from the base camp (paper, plastic etc.). The empty fuel drums, we will send back to the PCSP.

I hope that I could give you the necessary information. If I still need a permit by the Hamlet of Resolute, please tell me.
