# SUBJECT Nunavut Water Board Licence #3BC-DRA1012/TR/H2, Queens University, Drake Point Project, Qikiqtani Region, Addendum to Spill Contingency Plan

#### A. PROJECT DESCRIPTION

**FROM** 

On Sept. 21/10 the Nunavut Water Board (NWB or Board) provided notice of Queens University's an addendum to their project's Spill Contingency Plan that was received on July 7/10. This submission was made pursuant to Part H: Conditions Applying to Spill Contingency Planning, Item #2 of their water licence. Interested parties were requested to review this submission and provide written representations by October 18/10.

Part H, item #2 of the licence states,

The Licensee shall submit within thirty (30) days of issuance of the Licence, an Addendum to the Plan referred to in Part H, Item 1, in the format set out by the Consolidation of Spill Contingency Planning and Reporting Regulations R-068-93 addressing the following issues:

- a. Include a site map, set in appropriate scale depicting fuel storage facility in relation to areas that could potentially be affected in the event of spills;
- b. Include information on spill contingency training provided to participants;
- c. Provide a description of the type and amount of hazardous materials, including fuel stored in the project area; and,
- d. Provide information on disposal procedures for recovered contaminated material.

#### **B. RESULTS OF REVIEW**

On behalf of Indian and Northern Affairs Canada I am providing the following comments/ recommendations for the Board's consideration,

## **General Observations**

The submitted Spill Contingency Plan addendum adequately addresses the information requirements specified in Part H, Item #2 of the licence. Queens University should ensure that their project's Spill Contingency Plan is revised to include this submission (i.e., have a single comprehensive document).
