Here are the responses to your questions:

Response to Question 1: If you are solely responsible for the licence, then the declaration would be on your behalf; however, if the University of Colorado, Museum of Natural History (the University) is fully or partially responsible for the licence, then your declaration would be on behalf of the University.

Response to Question 2: With respect to the fees associated with the application, it can be in the form of a cheque, money order, or credit card. The cheque or money order has to be in Canadian dollars and made payable to the Receiver general for Canada.

Response to Question 3: As for the Certificate of Completion referred to under Block 9 of the application form, a final report that includes photographic records and details of site conditions on completion of the project should suffice. It should be noted that block 9 is aimed at obtaining information that confirms the project site has been restored to almost pre-project state.
