RE: <u>Licence No. 3BC-FOS1015 – Submission of 2012 and 2013 Annual Reports for the Fosheim Peninsula Project – Ellesmere Island Project</u>

Dear Dr. Pollard:

The Nunavut Water Board ("NWB" "Board") has reviewed the documents submitted for the purpose of satisfying the 2012 and 2013 annual reporting requirements for the above-mentioned project, located approximately 400 km north of Grise Fiord within the Qikiqtani Region of Nunavut. The review determined that the following information is absent from both documents and should be submitted to the Board for review before **November 3, 2013**:

- Requirements under Part B, Item 2 in Licence 3BC-FOS1015;
- The GPS co-ordinates (in degrees, minutes and seconds of latitude and longitude) of all locations where sources of water are utilized for all purposes, as required under Part J, Item 2 of the terms and conditions in the Licence; and
- The GPS co-ordinates (in degrees, minutes and seconds of latitude and longitude) of all locations where wastes associated with the camp operations are deposited as required under Part J. Item 3 of the terms and conditions in the Licence.

The above-mentioned documents were received on March 8, 2012 and January 17, 2013, respectively, and distributed publicly for information purposes shortly following receipt. The Board, however, has not been in receipt of any comments from interested persons to date with
