Hi Serge,

First off the Application for Certification of completion or certificate of closure, as far as i can tell do not exist in this case so do not worry about them.

Second, with respect to each of the listed files;

2BE-NBP0305; This project was recommended for closure by an Inspector in 2012. CIDM# 575228. This Inspector report was filed with the board. upon your application and assuming there are no outstanding fees etc the board may move directly to cancellation and a letter from the manager of field op's will follow;.

3BC-HPI1213: Our records indicate a Land Use Permit Final Plan (N2011N0031) was submitted (CIDM # 789523). A final Inspection is required on the site. An annual report for the water license for 2012 and 2013 are not on file however I suspect that the Final Plan as submitted for the land Use permit would suffice in this case. An annual report for 2013 would still be required however. Then upon submission of your application for cancellation and assuming there are no outstanding fees etc a Final inspection on the site will be completed and a recommendation for closure sent to the NWB, who would then close the file.

3BC-GEM0911 : With respect to this file I have an email on file indicating that a land Use Inspection was conducted in 2010 and a Water License Inspection completed in 2009. The sites were different because the Camp was moved each year.. Barrel Camp and a camp at Mackar Inlet. Upon submission of your application for cancellation the NWB will review their files to ensure that all Annual reports have been submitted and that no outstanding fees remain. Following that AANDC will conduct a final Inspection at the Mackar Inlet site and assuming all is found in order a recommendation to the Board can be made to close the license.
