Pursuant to its authority under Article 13.7.5 of the *Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada* and the *Nunavut Waters* and Article 49(a) of the *Nunavut Surface Rights Tribunal Act*, the Chief Administrative Officer of the Nunavut Water Board hereby approves the following license amendment.

The License issued June 22, 2004 shall be amended to include the following terms and conditions and to allow Matrix Aviation Solutions Inc. to undertake camp activities at the new Hope Lake Camp location (latitude 67°26'05"N; longitude 116°24'51"W).

## Licence NWB6HLC0406-Type "B"

Page 3 is amended to extend the expiry date of the Licence to June 30, 2007.

### Amend Part A to include enforcement

#### PART A: SCOPE, DEFINITIONS & ENFORCEMENT

Insert Item 3

#### **3. Enforcement**

- i. Failure to comply with this Licence will be a violation of the *Act*, subjecting the Licensee to the enforcement measures and the penalties provided for in the *Act*;
- ii. All inspection and enforcement services regarding this Licence will be provided by Inspectors appointed under the *Act*; and
- iii. For the purpose of enforcing this Licence and with respect to the use of water and deposit or discharge of waste by the licensee, Inspectors appointed under the *Act*, hold all powers, privileges and protections that are conferred upon them by the *Act* or by other applicable law.

## **PART B: GENERAL CONDITIONS**

Insert Item 1            The Water use fee shall be paid in accordance with the requirements of the Act.

## **PART C: CONDITIONS APPLYING TO WATER USE**

Amend Item 1            The Licensee shall obtain water for domestic use from the un-named creek that runs adjacent to the camp, up to a maximum of 1.5 cubic metres per day.

## **PART F: CONDITIONS APPLYING TO EMERGENCY RESPONSE**

Amend Item 1(i)        The addition of Environment Canada personnel in Iqaluit at 867-975-4644 and the Environment Canada 24hr pager at 867-920-5131 to the spill response contact list for Nunavut;

Insert Item 1 (vii)      Clearly indicate that immediate reporting is required of any spill to the NWT Spill Report Line at 867-920-8130;

Insert Item 1(viii)     include a copy of the NWT Spill Report Form as an appendix to the Plan to be used for reporting of spills;

Amend Item 2            The information required in Part F, Item 1 shall be submitted as an addendum to the approved Plan within thirty (30) days of issuance of Amendment No.1.

## **PART G: CONDITIONS APPLYING TO ABANDONMENT AND RESTORATION**

Amend Item 1            The Licensee shall submit to the Board for approval, within sixty (60) days of issuance of Amendment No.1, an Abandonment and Restoration Plan prepared in accordance with the applicable sections of the "Guidelines for Abandonment and Restoration Planning for Mines in the Northwest Territories (1990)".

All remaining terms and conditions of the License NWB6HLC0406 Type 'B' dated June 22<sup>nd</sup>, 2004 still apply.
