## 4. Inventory of hazardous materials stored on site and approx. amounts

Fuel – Diesel	15 drums (55 gallons per drum)
Fuel – Gasoline	10 drums (55 gallons per drum)
Fuel – Propane	10 tanks (100 lbs per tank)

## 5. Spill Plan Activation Procedure

In case of spill, follow the 4 steps below in sequence.

If you do not feel competent or adequately equipped, please seek assistance first.

### STEP 1: Immediate Danger?

*Assess hazard* presented by spill.

*Ensure* that no person is exposed to any immediate danger from spill.

*Evacuate* spill site immediately if immediate danger is present.

*Seek medical help* for any injured person.

*Inform HMP management or authorities* immediately as appropriate.

### STEP 2: Contain Spill – Use Spill Kit

If no immediate danger is present...

*Stop spill* at its source.

*Isolate spill*: Prevent expansion of the area affected by the spill.

*Continue* pursuing measures of STEP 1 through STEP 2.

### STEP 3: Clean Up Spill Site – Use Spill Kit

If no immediate danger is present...

*Assess damage* from spill.

*Stop damage* from expanding first, then begin site restoration.

*Clean up and restore* spill site using proper equipment and materials.

*Continue* pursuing measures of STEPS 1 through STEP 3.

### STEP 4: File Report(s) ASAP

*Assist* HMP Management in filing a detailed Nunavut Spill Report.

*Assist* HMP Management in filing any additional reports as needed.

*Assist* HMP Management in updating this plan as appropriate.

## 6. Spill Plan Effective Dates

The current plan will be effective from **1 Aug 2013** through **31 May 2018** unless otherwise modified.

## 7. Contents of HMP Spill Kits

There are two spill kits stored at HMPRS (Core). Each kit contains:

- Oil and petroleum absorbent pads
- Buckets
- Heavy duty garbage bags

## 8. Spill Reporting Procedure

A spills witnessed by HMP participants should be reported to HMP Management asap, as part of Step 1 of the Spill Plan Activation Procedure specified above.
