SUBJECT: STATUS OF FILE 3BC-ING0712

Dear Mr. Tapaai:

On November 22, 2012 the Nunavut Water Board received a letter from you indicating that you wished to cancel your water licence. In order for the NWB to comply with your request there are a number of items that require your attention:

1. Your water licence, 3BC-ING0712 is a valid document containing various terms and conditions required of the proponent. These are namely submissions of various reports and fees and compliance with any findings from the AANDC Inspector.
  2. Your file indicates that only one annual report has been received that is not dated. I will place a note on that inspection report to indicate it is for the years 2007 to 2012 inclusive, since you have indicated that the camp is only used for personal family use.
  3. It is my understanding from emails between yourself and the AANDC Inspector that a cancellation of the licence will be recommended. The Nunavut Water Board will not have a problem with that approach.
  4. As the water licence was issued and was valid from 2007 to 2012 there is still the requirement to pay the fees that are associated with it. Our office does not have the authority to waive these fees. They are outstanding as follows:
    - July 6, 2008 to July 5, 2009 = 30.00
    - July 6, 2009 to July 5, 2010 = 30.00
    - July 6, 2010 to July 5, 2011 = 30.00
    - July 6, 2011 to July 5, 2012 = 30.00
    - July 6, 2012 to Sept 30, 2012 = 7.15
- Total amount owing for outstanding water use fees is \$127.15.

Please forward an application for cancellation. One is attached for your use. There is a requirement to provide a \$30.00 administration fee for the cancellation so the grand total of fees to be submitted is \$157.15. Also please provide a translation of your cover letter in Inuktitut, attached is a copy for your reference.

Since you are requesting a cancellation of your water licence the requirement to submit an amended spill contingency plan has been waived.

Once we receive the application for cancellation, your cover letter in Inuktitut, and your outstanding fees, the Nunavut Water Board will send the application out of a 30 day review and comments. On recommendation from the AANDC Inspector we can then cancel your licence.

I trust the above is acceptable to you.
