Technical Review Memorandum

To: Phyllis Beaulieu - Manager of Licensing, Nunavut Water Board

Re: 3BC-MBP1010 - Renewal Application - Scientific Research - Mesoproterozoic Basins - Laurentian University.

Background

The Mesoproterozoic Basins Project is located in the High Arctic. There will be two camp locations for this project; one location is located 120 km southwest of Pond Inlet on the Alpha River just inland of Tremblay Sound. The other camp location is located 35 km east of Arctic Bay, just inland of Adams Sound in a northeast direction.

Each camp will be occupied by two or three people for a period of 1-3 weeks in the summer. Camps will consist of small sleeping tents with all Blackwater and Greywater being buried on site. There will also be small amounts of fuel on site for cooking and all Garbage will be deposed of at an approved landfill.

The purpose of the project is to conduct scientific research on the geology and rock formations of the High Arctic.

Recommendations/Comments


After reviewing the renewal application of 3BC-MPB1010 from Laurentian University, INAC would like to state that the application is well done. However, INAC has a few comments that need to be addressed and clarified.

Application

Land Use

INAC notes that part 6 of the renewal application is not answered.





INAC notes however, that in the renewal application the applicant has attached a list of coordinates where field activities will take place and what the land status is (i.e., Crown, IOL, etc.).

INAC recommends that the applicant answer part 6 of the renewal application based on these activities.

INAC notes that the applicant did not provide written confirmation from the Nunavut Planning Commission (NPC) that no conformity review is required for the renewal.

INAC recommends that the applicant provide the NPC written confirmation, that no conformity review is required, to the NWB.

Water Use

INAC notes that in part 13 of the renewal application the applicant answers **Yes** to the question "are they using the same water source as in the existing water license." However, in part 4 of the renewal application the applicant answered **No** to the question "is the location the same as in the existing license."

INAC recommends clarification into the seemingly contrasting answers of different locations from previous license, however using same water sources.

<u>Waste</u>

INAC recommends that the applicant provide, to the NWB, written approval from both Arctic Bay and Pond Inlet before disposing of any wastes into the Hamlet's approved landfill.

Other Authorizations

INAC reminds the applicant that their research license issued by the Nunavut Research Institute, #02 062 10R-M, expired on December 31, 2010. This licence should be renewed. Once confirmation that a renewed license has been received a copy should be send to the NWB.

INAC recommends that the applicant provide, to the NWB, all of the above referenced outstanding information pertaining to the renewal application for 3BC-MBP1010 before the application is approved by the NWB.
