## DECISION

### LICENCE NUMBER: 3BC-MBP1114

This is the decision of the Nunavut Water Board (NWB) with respect to an application dated February 2, 2011 for renewal Water Licence made by:

#### ELIZABETH C. TURNER

to allow for the use of water and disposal of waste during camp operations in support of research at the Mesoproterozoic Basin Project located within the Qikiqtani Region, Nunavut generally located at the geographical coordinates as follows:

Latitude: 72° 57' 20" N	Longitude: 84° 09' 12" W (Camp)
Latitude: 72° 25' 05" N	Longitude: 81° 23' 47" W (Camp)

## DECISION

After having been satisfied that the application was in conformity with the North Baffin Regional Land Use Plan<sup>1</sup> and exempt from the requirement for screening as described within Section 12.4.3 by the Nunavut Impact Review Board<sup>2</sup> in accordance with Article 12 of the *Nunavut Land Claim Agreement (NLCA)*, the NWB decided that the application could proceed through the regulatory process. In accordance with S.55.1 of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act (Act)* and Article 13 of the *NLCA*, public notice of the application was given and interested persons were invited to make representations to the NWB.

After reviewing the submission of the Applicant and considering the representations made by interested persons the NWB, having given due regard to the facts and circumstances, the merits of the submissions made to it and to the purpose, scope and intent of the *NLCA* and of the *Act*, waived the requirement to hold a public hearing, and determined that:

**Licence No. 3BC-MPB1010 be renewed as Licence No. 3BC-MBP1114 subject to the terms and conditions contained therein. (Motion #2011-04-14 ~~2011-04-L02~~)**
