I am commenting on your correspondence with the Nunavut Water Board on your 2008 water licence. Unless the NWB cancels the water licence, the terms and conditions of the water licence continue to apply and the INAC inspectors will enforce either the licence or under the federal Nunavut Waters and Nunavut Surface Rights Tribunal Act.

You can apply to have the NWB cancel your water licence by providing your reasons for cancellation, which in your case is completion of the research project, and a description of the measures taken to leave little surface disturbance and effects on water. An Application for Water Licence Cancellation may be found in Appendix D of the NWB Guide 7 "Licensee Requirements following the Issuance of a Water Licence" on their ftp site (ftp://nunavutwaterboard.org/NWB%20GUIDES/100401-Guide7-ActivitiesFollowingIssuanceWaterLicence-OEDE-edited100601.pdf).

I would also like to remind you to provide a copy of your research as required under your research permits. If you had canceled or completed your work under your research permit through the Nunavut Research Institute as outlined under the federal Nunavut Archaeological and Palaeontological Sites Regulations under the Nunavut Act, NRI would have informed the NWB.

You may also have applied for and received a 2 year land use permit if you had occupied a site for more than 100 man-days. You should have informed the surface land owner(s) that the project was completed so any necessary inspections of the site could be done.

Hopefully this email will clarify any further work required by yo to cancel your water licence.
