Dear Atuat,

I'm writing up to follow up on the inspection that you did of my site at Purple Valley, Ellesmere Island, in July. I was wondering if everything was OK?

I was at Purple Valley from July 10-13 this year, and completely cleared out the old cache of material when I left (old sled, fuel barrels, etc.). Today there are just 4 new drums of jet fuel left at the site (in a berm), together with my weather station. Since the regulations have changed for water licenses, we can now operate at the site by getting an exemption from NWB each year. I would therefore like to close out my old water license (3BC-NEI1215), and to do this I need a 'Certificate of Completion' which includes a site inspection report. Are you able to provide this?
