A. Background

On March 24, 2015, the Nunavut Water Board (NWB) distributed a cancellation application from Defence Research and Development Canada for water licence #3BC-NWT1113. Defence Research and Development Canada is requesting to cancel the expired water licence and continue all on-going project activities with an authorization for Approval for the Use of Water or Deposit of Waste without a Licence. An Authorization without a License has already been issued by the Board for this activity.

The Northern Watch Technology Demonstration Project is situated approximately 110 km east of the Hamlet of Resolute on Devon Island, north of the Brodeur Peninsula. Project activities consist of operating arctic marine environment surveillance systems (underwater and land-based) from mid- July to mid- September. Project personnel are accommodated in a camp that is supported by an airstrip. This camp can accommodate twenty (20) people.

B. Results of Review

1. Fuel Storage

Comments

AANDC recognizes that the fuel storage is stated in *Table 1: Spill Contingency Plan – Site Information (Storage)* in the Spill Contingency Plan and that there is a legend provided for quantities of fuel stored on site.

Recommendations

AANDC recommends that the licensee provided a more clear record of quantities of fuel stored on site.



2. Cancellation of Licence

Considering that all relevant activities previously licensed and subject to the *Nunavut Waters and Nunavut Surface Rights Tribunal Act* are now regulated through 8WLC-NWT1415, Aboriginal Affairs and Northern Development Canada, Field Operations Unit supports the cancellation of 3BC-NWT1113.
