Good Morning Peter,

Thank you for your inquiry. I will do my best to assist you in any way I can.

First, The expired license 3BC-PRO0914,

CASP has transition-ed to the new Approval Without a License process that the Nunavut Water Board (NWB) has initiated.

This is great but the expired license still exists and must be canceled. This is done through an application for closure to the NWB.

Phyllis would be the best person to discuss this with and can provide you the easiest process to follow. Note that an Inspection was completed (2014) on the sites listed and the License was recommended for closure in the Inspection Report so a simple request to the Board should facilitate this very quickly.

With respect to the approval without a license issued by the board (8WLC-PRO1415) Expiring on February 23rd , 2015. A Summary Report is due to the Board within 30 days following the expiry of this authorization,

unless a new authorization is issued within that 30 day period. The application for renewal should be sent directly to Phyllis at the Nunavut Water Board as soon as possible to ensure the timely review of your application and a renewal of your authorization prior to March 31st 2015 at which point a the Summary report and a new application would be required.

The Assessment form should be filled out for your project regardless of what authorizations you have (ie: a Water License, Authority without a license, Land Use permit or Quarry Permit).. This assessment allows us to prioritize our Inspection planning by determining the level of activity individual projects carry with them and the impact (if any) they may have. This allows us to ensure that those activities that carry a higher risk are identified and managed properly within the Regulatory system.

I hope this is clear.

I do not have a copy of the application for renewal so I can not forward one to you from this office, I apologize and will take steps to obtain one so that I may also send them to clients upon request. This is clearly an oversight on my part and I apologize for the inconvenience.

It has come to our attention that the above noted Water license for work conducted between 2009 and 2014 has expired. A review of the file submissions is unable to produce either an application for renewal or an application for cancellation of the expired License. It is AANDC's understanding that the above noted license was replaced by the Nunavut Water Board with an annual Authority without a License (8WLC PRO1415) however the final disposition of the expired license must still be addressed.
