Good afternoon Peter and thank you for your email. All that is required is an amendment to your current licence. I've attached the amendment application for your use. There is a \$30.00 administration fee for the amendment. This can be paid either by cheque, visa or money order. If paying by cheque or money order please make payable to Receiver General.

You also have the option of applying for an approval without a licence and I've attached the Nunavut Waters Regulations and the application form for you, if you choose this option. This will save you the application fee and water use fees that are normally associated with a regular water licence. There is, however an outstanding water use fee of \$30.00 outstanding on your current licence that will need to be paid before we will consider an approval without a licence. This fee was due and payable on June 17, 2013.
