## SOUTHAMPTON ISLAND INTEGRATED GEOSCIENCE (SIIG): PROJECT DESCRIPTION AND UPDATE OF ACTIVITIES

Joyia Chakungal and Mary Sanborn-Barrie, Project co-leaders

In 2007, Southampton Island Integrated Geoscience (SIIG) project was initiated with funding support from the Canada – Nunavut Geoscience Office, Geological Survey of Canada, the Polar Continental Shelf Project, the Department of Indian Affairs and Northern Development, and the Government of Nunavut. The principal objectives of the project included: 1) acquisition of high-resolution, regional aeromagnetic data for the central and eastern portions of Southampton Island (completed on August 24<sup>th</sup>, 2007), and 2) helicopter supported acquisition of ground-based bedrock and surficial geology data from a tent-based research camp situated approximately 30 km northwest of Coral Harbour (N 64° 36′ 46″, W 84° 06′ 31″; refer to attached map). Between July 7 and August 25, 2007, approximately 11,000 km² of the bedrock and surficial geology of central and northern Southampton Island were mapped at a scale of 1:250,000. Approximately 500 rock; 200 till (soil) samples were collected over the course of the summer. Analysis of the samples (ongoing) will provide new data and ideas intended to promote the exploration potential of the island.

Following complete demobilization of the Southampton Island Integrated Geoscience research camp on August 25<sup>th</sup>, 2007, four members of the hamlet of Coral Harbour were asked to visit and inspect on behalf of the community the camp site. The inspection crew included Mayor Armand Angootealuk, MLA Patterk Netser, and HTA members Louisa and Noah Kudluk

To complete the work started in 2007, the east and southeast parts of the island remain to be mapped at 1:250,000 scale. Data pertaining to this region is critical for an integrated understanding of the geology of the island, particularly since it occurs outside the area for which regional geophysical information is now available. With this in mind, an application for logistical support has been submitted to the Polar Continental Shelf Project in which we have proposed to complete the geological map in 2008 with a team of approximately 6 scientists, university students, and employees based in Coral Harbour. Names of the individuals who will be part of the research team will be provided in May, once the team has been finalized. The work is intended to be based from a helicopter supported research camp located in the hamlet of Coral Harbour and carried out between July 7<sup>th</sup> and August 6<sup>th</sup>, 2008. With this in mind, 80 drums of Jet-B fuel have been cached at the Coral Harbour Airport, and will remain so for the duration of the work proposed for 2008.
